

SEVIER COUNTY CHANCERY COURT FEES
ALL FEES REQUIRED IN ADVANCE (Revised 10/4/2018)

CATEGORY #1 – Contracts, torts, personal injury, property damage, malpractice, wrongful death, employment discrimination, civil rights suits, tax disputes, special remedies, & cases not otherwise specified (Up to 10 defendants) **\$374.50**

CATEGORY #2 - Worker’s compensation cases, appeals from lower courts, administrative hearings, and transfers from foreign counties. **\$299.50**

CATEGORY #3 – Adoptions, legitimations, paternity cases, termination of parental rights and other domestic relations matters not otherwise designated, name changes, minor settlements, enforcements of foreign judgments, and (orders of protection -fees not required in advance). **\$249.50**

ADOPTIONS (Add **\$30.00** per child to change birth certificate and 1 certified copy. Extra certified copy is \$15.00 <Tennessee births only>). Out of state-actual cost.

CATEGORY #4 – Child support enforcement and modification **\$ 77.00**

GUARDIANSHIPS & CONSERVATORSHIPS **\$ 309.50**

Divorce (with minor children) **\$ 349.50**

Divorce (without minor children) **\$ 274.50**

Order of Protection (fees not required in advance) **\$ 249.50**

PREPARING RECORD ON APPEAL----- **\$ 300.00**

THIRD-PARTY COMPLAINT-(do not charge Lit Tax \$147.50)---- Same as original

Fees for service of process (Summons & Subpeonas) are to be paid in advance, including Sevier County (Make payable to appropriate Sheriff’s Department)-----**\$42.00** per person

Fees for Service (Wage garnishment) -----**\$22.00** per person

Writ of Attachment -----**\$42.00**

Non-resident service- The Mountain Press **\$80.00** (extra charge if ad exceeds 7.5”)
Tennessee Star Journal **\$36.00**

Secretary of State (per person) payable to Secretary of State-----**\$20.00**

Commissioner of Insurance (payable to Comm. of Insurance)----- **\$15.00**
